## PROFESSIONAL CERTIFICATION DESIGNATIONS

Examples of individuals joining the International Real Estate Institute include: Real Estate Consultants, Property Managers, Real Estate Investors, Real Estate Appraisers and International Property Consultants.

### ***RPM – Registered Property Manager***

This designation is offered to property management professionals throughout the world.

### ***SCV – Senior Certified Valuer***

This designation is offered to real estate professionals practicing the valuation of real estate.

### ***CIC – Certified International Consultant***

This designation is offered to professionals with a broad range of expertise on international real estate investment, development, valuation, and property management.

### ***RIM – Registered International Member***

A designation offered to those individuals involved with finance, development, and investment of real estate.

### ***Affiliate Member***
